THANK YOU FOR YOUR DONATION. AS NOTED ON THE FRONT SIDE OF THIS FORM, YOU HAVE REQUESTED YOUR GIFT BE USED FOR A SPECIFIC CHILD, HOME, FAMILY OR PROGRAM. THE IRS HAS GRANTED US PERMISSION TO RECEIVE TAX-DEDUCTIBLE DONATIONS, BUT THEY HAVE ALSO ESTABLISHED VERY STRICT REGULATIONS CONCERNING DESIGNATED GIFTS. WE HAVE INCLUDED A SUMMARY OF THE REGULATIONS FOR YOUR REVIEW BELOW:

Designated Giving:

“When there is designated giving, the organization must have the ability to access and use the proceeds of said gift for general program purposes. The contribution cannot be set aside for use by a specific person. The organization must have the discretionary ability over the money to qualify the gift as a tax-deductible gift for the donor. Gifts must have no strings attached as to a specific individual being the benefactor of that gift. A tax-deductible gift may only be claimed if the gift was given to the organization in general, but not to a specific person. That is an illegal pass-through of funds. In such cases, the money would be considered a personal gift to the specific recipient and the organization should not be involved. No tax benefits arise from such a gift.”
